1. Call to Order

M.Trepanier calls meeting to order at 6:00pm PDT.

2. Financial Update

- R. Cryder provided an update of the financial situation and projected bookings, referring to the Overnight Revenue Report June 29 – November 30 and PM Board Update Sept 5, 2020.
- August was a strong month as has been the beginning of September.
- In contrast, October and November are showing weak advanced bookings.

3. Review of Proposed Fall Closure Schedule

- R. Cryder reviewed the closure schedule outlined in the proposal.
- With some flexibility on specific dates, all hostels are to close in late September or early October.
- Some wilderness hostels and HI Whistler, HI Banff, HI Lake Louise and HI Banff will re-open on December 18. Other hostels will not re-open until Spring 2021.
- The Board of Directors supported the plan through the following motion.

4. Potential Leasing of HI Calgary and HI Edmonton

- R. Cryder advised that the Alberta government has expressed interest in leasing HI Calgary and HI Edmonton.
- Representatives of the provincial government have toured HI Calgary.
- Information about the properties had been provided to the provincial government.

5. Human Resources Update

- R. Cryder advised that 75 employees that are either working or on layoff had been given working notices and terminated.
- During the closure, employees will be taking vacation to reduce the vacation accrual being carried by the association. Vacation days are eligible for the federal wage subsidy.

6. Board Retreat

- K. Keener provided an update on the 2020 Board Retreat.
- Advised that it will be beneficial to provide information about Board Committees to new Board Members in advance of the retreat.

7. October Board Meeting

- Date was set for October 17 & 18.
- K. Keener will advise new Board Members.

8. HI C Funding Formula

- P. Nietresta raised concerns about the indefinite closure of hostels and its impact on the funding of HI C.
- R. Cryder will contact Sylvianne to obtain the details of the funding formula and data for the past year.
